<b>R</b> - Ready Reserve Member in the Individual Ready Reserve (IRR)	<b>E</b> - Trained Member of the Ready Reserve not in SELRES
	<b>M</b> - Special Category within the IRR subject to Involuntary Call to Active Duty
	<b>H</b> - Untrained Member of the Individual Ready Reserve (IRR) in the Delayed Entry Program (DEP)
	<b>U</b> - Personnel Awaiting IADT and not authorized to perform IDT or receive pay
<b>P</b> - Ready Reserve Member in a Ready Reserve Training Program	<b>J</b> - Ready Reserve Member not in the SELRES and participating in Officer Training Programs
	<b>K</b> - Ready Reserve Member not in the SELRES and participating in the Health Professions Scholarship Program (HPSP)
<b>I</b> - Ready Reserve Member in the Inactive National Guard (ING)	<b>I</b> - Ready Reserve Member in the Inactive National Guard (ING)
<b>Y</b> - Standby Reserve	<b>C</b> - Standby Reserve Member on the Active Status List as a Key Employee
	<b>D</b> - Standby Reserve Member on an Active Status List Program
	<b>L</b> - Standby Reserve Member on an Inactive Status List vice separated due to a less than 30% service disability
	<b>N</b> - Standby Reserve Member on an Inactive Status List vice separated for other reasons
<b>V</b> - Retired Reserve	<b>1</b> - Reserve Member eligible and receiving Non-Regular Retirement pay based on 20 or more Creditable Anniversary Years
	<b>2</b> - Reserve members who have completed the requisite qualifying years creditable for non-regular retired pay but not yet eligible to receive retired pay, or are eligible to receive retired pay but have not applied for such pay
	<b>3</b> - Reserve Members receiving Non-Regular Retirement pay for Physical Disability and has 20 years of Creditable Anniversary Years or 30% disabled
	<b>4</b> - Reserve Member receiving Regular Retirement pay based on completion of 20 years or more of active duty
	<b>5</b> - Reserve Member receiving Regular Retirement pay for other than age/service requirements or physical disability
